

**Vermillion County Commissioners**

- I. Call to order. The Vermillion County Commissioners convened in a regular meeting at 6:00 p.m. on Monday, October 3, 2016.
- II. Roll call. Members present were President Tim Wilson, Vice-President Harry Crossley, Tim Yocum, Auditor Phyllis Orman, Chief Deputy Auditor Amy Tolbert, and Attorney Jon Spurr.
- III. Approval of minutes from last meeting. Crossley made a motion to accept the minutes from September 20, 2016, seconded by Yocum. Motion carried.
- IV. Approval of claims and payroll. Crossley made a motion to accept the claims and payroll for release on October 7, 2016, seconded by Yocum. Motion carried.
- V. Open issues
  - a) Property for Walking Trail. Yocum said he is still in the process of acquiring a legal description for the proposed walking trail near Hillsdale.
  - b) Jail Water Pressure. Yocum said HWC is in the process of completing the plans.
  - c) Jail geothermal and energy savings. Three requests for qualifications were received from Ameresco, Performance Services, and ESG Energy Systems Group. Crossley made a motion to forward the proposals to the Energy Savings committee for review and recommendation, seconded by Yocum. Motion carried.
  - d) Eugene Covered Bridge abutment. Nothing new to report at this time.
  - e) Post Frame Building for District II. Nothing new to report at this time.
  - f) Grant Writer. The commissioners discussed hiring a grant writer for the county. They agreed to talk to West Central Indiana Economic Development District for recommendations and suggestions.
  - g) Bid for 100W/1200 S. Three bids were received, Kanizer Excavating \$37,900, Lubovich Excavating \$25,315.65 and Eric Smith who did not have a bid bond so was disqualified. Crossley made a motion to accept the low bid from Lubovich Excavating, seconded by Yocum, motion carried.
  - h) Vermillion Rise Update. Nothing new to report.
- VI. New business
  - a) 2017 Holiday Calendar. Wilson suggested keeping the election days and giving them as personal days. Crossley did not think that was a good idea.
  - b) Bridge 122. Yocum said the state changed the plans and now they want the creek dredged. The county will have to let bids on this project and will be around \$30,000.00. Crossley said they will need to look and see if there are funds available.
