

NOTICE TO BIDDERS

BIDS FOR SUPPLIES, MATERIALS OR SERVICES FOR VERMILLION COUNTY, INDIANA

Notice is hereby given that the Board of Commissioners of Vermillion County, Indiana, will receive sealed bids on December 27, 2017 at 8:15 a.m. in the Commissioners Courtroom, Courthouse, Newport, Indiana for supplies and materials, or services for Vermillion County Departments and/or Offices for the year 2018.

Bids will be received on each item as listed on the following schedule.

All bidders shall furnish with their bid, a bid bond or certified check in the amount that is set out in the various specifications on or before December 15, 2017, by 4:00 pm. in the Courthouse Auditor's Office, P.O. Box 190, Newport, Indiana 47966.

All bids must be properly labeled on the outside of the envelope as to the kind of bid enclosed.

1. Gasoline for the Sheriff's Cars and Parks Department
2. Gasoline and Diesel Fuel for Highway Vehicles
3. Oil and Grease

Bids must be sealed and filed on State Board of Accounts Bid Form No. 95. Each bid must have a bid bond or certified check in the amount of ten percent (10%) of the bid.

4. Treated Timber Bridges and Drainage Structures and Materials

Bids must be sealed and filed on State Board of Accounts Bid Form No. 95. Each bid must have a bid bond or certified check in the amount of ten percent (10%) of the bid.

5. Gravel and Sand and Stone for Highway Department.
6. Pit Run Gravel for Highway Department.

Bids must be sealed and filed on State Board of Accounts Bid Form No. 95. Each bid must have a bid bond or certified check in the amount of ten percent (10%) of the bid.

7. Bituminous Materials, Liquid Asphalt, Plan Mix and Patching.

Bids must be sealed and filed on State Board of Accounts Bid Form No. 95. Each bid must have a bid bond or certified check in the amount of ten percent (10%) of the bid.

8. Culverts and All-Steel Bridge Packages

Bids must be sealed and filed on State Board of Accounts Bid Form No. 95. Each bid and must have a bid bond or certified check in the amount of ten percent (10%) of the bid.

Courthouse Auditor's Office, Second Floor, Newport, Indiana 47966.

The County reserves the right to award bids based upon geographic areas to more than one responsible and responsive bidder based upon the availability of service in the specific geographic areas.

The Board of Commissioners reserve the right to reject any or all bids or waive technicalities as to award bids that in their judgment are most advantageous to Vermillion County.
