State Update

The Mandatory carding has been repealed. Some think, "It is working, why change it?" Some store owners will continue to card everyone, regardless.

Alcohol must be displayed separately beginning January 19. This only pertains to distilled spirits. This requires owners to display these items separate for other retail items for sales.

Law Makers discuss the requirement of a prescription to use Pseudonephrine. Law enforcement officials are behind this law. In Oregon, when this requirement became law, meth labs went down 90%.

Indiana begins to receive state mandates on return or unused scripts. Most counties are adopting policies to help with this issue already.

The Smoking ban passed out of the house into the Senate with exception - more to follow.

HB1233 - Involves the end of ITPC.

The state also looking at Public Intoxication as a lessening penalty and reduce housing issues.

Coordinator Update:

Elaine has the Probation Departments date for the CCP update.

Brian will obtain the Excise Police date on tazer use and effectiveness.

Tobacco Coordinator Update –

Flyers - text messaging for QUIT NOW. Individuals will receive texts 3 times a week to help quit now. As they no longer offer NRT's.

Michelle gave out Quit Cards and Tear off sheets.

The State passed the K2 Spice law - now illegal across the state with 5 ingredients.

Michelle spoke at NV to all classes and works with SV VOICE on the 18th and intends to speak to the 8th/6th graders on the 8th.

Tar Wars will begin a little late this year. More to follow.

Tobacco Cessation Symposium upcoming for mental health March 23 at the Indiana Government center.

Some individuals are smoking and sniffing bath salts now.

Michelle will attend a Tobacco conference in April at Virginia.
